

## **KRAFT HOLD FOR HEINZ SWEEPSTAKES (the "Sweepstakes") OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

**1. TO ENTER:** Participation constitutes entrant's full and unconditional agreement to, and acceptance of, these Official Rules. Sweepstakes begins 8:00 AM CT on February 25, 2021 and ends at 11:59 PM CT on February 28, 2021 (the "Sweepstakes Period"). During the necessary hold time, the word "LOADING" will appear. Upon successful completion of the necessary hold time, "CLICK TO ENTER" will appear. Tap or click on the "CLICK TO ENTER" button and complete and submit the official entry form. Once the entry form is verified, entrant will receive one (1) entry ("Entry") into the random drawing. Leaving the page while "LOADING" appears will result in the necessary hold time restarting. Participation with less than the necessary hold time of 57 consecutive minutes will not result in the official entry form appearing.
